4.1. Budget preparation for FY 15/16

- Executive Director Hackett and the committee discussed the FY15/16 projected budget. Items discussed included the JPA Administration budget, class 60, the million dollar cap, the lump sum contract provisions, class 40, GEMT monies usage, and some errors in the County's 5 year projected budget.
