### **MINUTES**

**Present:** Jody Gossner/CAL FIRE; Chief Tom Keating/Rescue; Battalion Chief Mike Webb/CAL FIRE - CPFD; Assistant Chief Mike Hardy/EDC Fire; Chief Dave Roberts/EDH; Chief Bruce Lacher/EDC Fire; Battalion Chief Justin Sanders/CALFIRE- ECC; Battalion Chief Joe Tyler/CALFIRE - CPFD; and Brian Veerkamp

Chairman Hardy called the meeting to order at 8:40 a.m.

### 1. Approval of the Agenda

Battalion Chief Webb motioned to approve the agenda. Chief Keating seconded the motion which carried unanimously.

### 2. Review cost savings and generate more money

Executive Director discussed a targeted amount of \$900,000.00

### Discussion Items

- ALS engine companies receive a stipend from the JPA
- ALS is \$7500 (non-provider)
- BLS is \$5000
- Statistics on ALS & BLS Transports needed.
- Core mission is ALS transport.
- Chief Hardy says we've been tracking data on ALS for over a year; however, response times reveal the needs for areas in 2 locations Pioneer and Cool.
- Each year EMS Agency, Rich Todd conducts annual survey on ambulance fees.
- County absorbs non-insured costs / Outsource collections to private agencies are more successful at collecting than the county.
- Important to maintain lower ambulance rates.
- Cannot cut services until we look at all potential cost savings.
- Chief Roberts asked if we've ever audited the special tax to see if we have missing fees.
- Chief Combs mentioned when TRA merged we should audit to see exactly what we're receiving.
- Director Hackett explained that with the passing of AB 678 Wittman stated that we can potentially see \$400,000 per year.

Ideas to increase Revenue

- Examine collections for improvements.
- \$25 ambulance fee public fees how much are we really getting?
- Estimated property tax/fees and fines are taken off the assessed amount before they are given to Fire Districts.
- Departments have decreased in number open pay scales at 30% less for entry level firefighters. This is more cost effective.
- Expenditures need to be explored regarding costs before we cut services ie: raising fees and assessments shouldn't happen until we re-evaluate our costs.
- Are we getting 100% of transfers of Marshall Transfers?
- 911 calls originate in our county assembling an ordinance with IFT EMS to enter discussion to transport outgoing calls.
- Convert 26 to BLS car or turn back to ALS.
- Leave ALS unit but utilize as BLS which would only require policy change, but would pick up more calls at 100% paid. ALS can go on all calls including BLS better customer service and revenue guaranteed.
- 2 paramedics are on each unit one ALS, one BLS / Can JPA pay for one paramedic and one EMT on each unit?
- Change master contract with Marshall without bringing on an added Unit. Explore handling more calls instead of shutting units down.
- Explore Responses.

#### Cost Savings

- \$17,000 savings on disposable towels
- Medic Units are huge expenditures that only have a 5 year life span / chassis and remounts are being performed to keep life of unit and cut costs
- Reduce Memberships costs
- Setting a standard for all FPD
- Cost controls should come out of the JPA track costs and set control caps / standardization

Adjournment Director Keating motioned to adjourn the meeting at 11:00 a.m. Deputy Chief O'Camb seconded the motion which carried unanimously.
