4. Old Business

4.1. Response Time Reports/Medic Move-Up Statistics for February

• Director Hackett provided highlights from the report. No change in Areas where exceptions occur. No visible address and incorrect time stamp reason for exception increased. Move up increase in February with one exception (M17).

4.2. Transfers

 MAC discussed 'Urgent' term usage by Marshall. Chief Cordero indicated improvement in this process now. Chief Sanders requested the Chiefs let the Command Center know if they encounter problems related to this.

4.3. Miwok Contract Status/Impact

 Marty Hackett/Rich Todd – County Counsel still in negotiations with the Tribe. They paid November and December however short paid the allowable 5% increase. They have been invoiced for January and February.

4.4. Discuss and Recommend Controlled Substance Security

- Director Hackett A meeting was held last week at Cameron Park. Group discussed improved security measures.
- Rich Todd talked about the responsibility of each agency to manage the security to Federal requirements and decrease liability.
- Rich Todd said at MAC meeting Kim George said Target Solutions offered an online narcotics log.

4.5. Review and Recommend ALS Ambulance Agreement with Updates

• Chairman Sanders – Discussion of the wording under section 51. Some Chiefs expressed concern of its impact on recruitment/hiring pool as currently written. Other Chiefs feel maturation needed prior to the hiring. Discussed a common standard or process for internship minimum in service process for new hire paramedics before they can staff the ambulance and meet the needs of the entire county. They have all graduated the academy with FF1. Chief Sanders indicated their agency and others staff ambulances only with Engineers or Captains. An internship alone does not meet the requirement.

Motion by Chairman Sanders for item 51 verbiage change to strike out 'and be certified by', add 'of' before 'the State Fire Marshal's Office as a Firefighter 1' and leave the remainder as written; Chief Cordero seconded.

Discussion. Chief Cordero suggested adding in time-frame to be certified. Chief Roberts discussed the idea of common testing standards and internal academy.

5. New Business

5.1 West End Move Up and Cover

 Captain Mitchell had indicated leaving medic 85 in medic 85's response area is better statistically. She was to provide data to this fact but is unavailable today due to training. Chief Keating suggested we try at 86 to see impact. Medic units will be status in the system as they actually are. Chief Keating will contact ECC Dave Wood about the change. Will move this item to old business next month and want statistics.

5.2 Review and Approve Updated EPCR Policy

 Director Hackett – Changes to item C. Documentation addition; only agency supplied desktop or iPad, no personal electronic devices used in EPCR viewing or accessing. If someone doesn't work here anymore, must be notified by agency immediately to disable access.

Motion by Chief Keating to approve as updated to go to the board, seconded by Chief Ransdell and carries unanimously.

Discussion: Rich Todd PAC modifying EMSA/County EPCR policy then will go to MAC. We need to have the two policies mirror each other or married into one. Director Hackett will work with EMSA to ensure if changes are made to the County policy, that the JPA policy is re-reviewed by this Committee.

6. Committee Reports

6.1 EPCR Working Group

 Forte believes they have an improvement for PCR attachment process. They will add folder function for any addendum or attachment to go into the folder for that PCR without having to open the PCR. Then the entire folder to go to Wittman for billing

6.2 MAC Committee

Todd/Hackett – Discussion at MAC concerning controlled substances/quantities on urban engines since ambulance will be there quickly. Chief Keating asked about census update because that could impact who carries narcotics and who doesn't. Discussion of PCS forms: Marshall will work on getting the forms completed correctly/signed. Rich Todd sent a copy of the SLT PCS form that can be completed on the iPad to Michele Williams to look at. Can bump it to the iPad.

6.3 Ambulance Spec Committee

Rebuild 4 will be delivered to the radio shop tomorrow. Build 5 starting this week. Reserve
units have high miles and are Fords. Recommending 3 remounts in the next fiscal year.
Cost effective to use the boxes on the remounts. Rich Todd should hear back from CAOs
office by tomorrow regarding the surplus requests.
